

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.whitewateragency.com, and White Water Agency LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to White Water Agency LLC include www.whitewateragency.com and White Water Agency. The White Water Agency website is a Promotional website and ecommerce for services provided by White Water Agency. site. By using the White Water Agency website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, White Water Agency may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Employer
- Job Title
